Subject: Policy for providing compassionate appointment to dependents of Haryana domicile Battle casualty who served in Armed Forces/Paramilitary Forces/Indian Coast Guard/Border Road Organization.

Sir/Madam

I am directed to invite your attention to the Government letter No.1/20/2013-1GS-II, dated 30.05.2014 & 27-08-2014 vide which compassionate assistance by way of appointment on compassionate grounds in the feeder cadre in Class-III and IV posts to one eligible living spouse/dependent children of Martyr of Armed Forces Personnel/Para Military Forces Personnel, who was domicile of Haryana and killed in action in border skirmishes, terrorists attacks or riots in addition to other financial benefits, was granted to the bereaved family.

- The matter of grant of Class II jobs to dependents/family members of deceased martyrs/battle casualty has been under consideration of Government.
- Government has now decided to grant Class II jobs also to those dependents/family members of deceased martyrs/battle casualty only in such cases where martyrs/battle casualty was Class I or Class II officer.
- The following conditions are laid down for grant of compassionate assistance by way of appointment on compassionate grounds, in Class II, III & IV posts:-
 - The consideration shall be made in respect of one eligible family member of bonafide domicile martyr/battle casualty of State of Haryana.
 - (ii) The definition of eligible family member as defined in policy dated 30.5.2014 is now amended as: dependent

son, daughter (married or unmarried) or spouse or brother of battle casualty or legally adopted son/daughter, provided the adoption was done when deceased soldier/battle casualty/martyr was alive.

- (III) The consideration of eligible dependent/family member of battle casualty shall be as per preference indicated by immediate Next of Kin.
- (iv) As per policy dated 30.5.2014, the compassionate appointment was only in respect of feeder cadre in Class III & IV posts. Government has now decided that the eligible family members shall be considered for direct recruitment in Class II, III or IV posts, as the case may be, keeping in view their educational qualifications, eligibility criteria and provisions as laid down in the recruitment rules for the concerned post. However, the applicant would be eligible for getting a Class II job only in such cases where martyr/battle casualty was Class I or Class II officer.
- (v) The consideration shall be admissible even if one or more members of the family of martyr/battle casualty is/are in service.
- (vi) Any relaxation with regard to age (18-42 years with relaxation of 5 years for SC/BC) and time limit (previous 3 years from date of commencement of this policy) shall be made with the prior approval of Council of Ministers.
- (vii) The request for grant of employment shall be made by the dependent of martyr/battle casualty soldier to the concerned Deputy Commissioner within a period of three years of death. In case where none of the son/daughter of the deceased is major, the time limit in such event will be attainment of 18 years by the eldest son/daughter, as the case may be.
- (viii) The request received by the Deputy Commissioner shall be forwarded to the Sainik & Ardh Sainik Welfare Department for consideration and appropriate action.
- (ix) The District Salnik Welfare Officer shall scrutinize the documents of the applicant relating to domicile status and martyr/battle casualty status of deceased (i.e. killed in action in border skirmishes, terrorist attack, riots etc.), whether deceased has been declared martyr/battle casualty by respective organization, age and educational qualification of applicant, NOC of Next of Kin, etc. and submit the same to the Deputy Commissioner.
- (x) With a view to ensure availability of posts and consequent appointment without delay, the concerned Deputy Commissioner shall ascertain the vacancy position and coordinate with the appointing authority before recommending the case.
- (xi) The consideration shall be made only against direct recruitment quota post.

(xii) Cases of those persons who have been already granted jobs under earlier policies dated 30.5.2014 and 27.8.2014 (1/20/2013-1GS-II) shall not be reopened.

All other terms & conditions as issued vide letter No.1/20/2013-1GS-II, dated 30.05.2014 and 27.8.2014 shall remain unchanged.

Subject:- Policy for providing Compassionate appointment to a dependent of Martyr of Armed Forces Personnel/Para Military Forces Personnel of domicile of Haryana.

Sir/Madam,

I am directed to refer on the subject cited above and to say that Haryana Government has decided to grant the compassionate assistance by way of appointment on compassionate grounds in the feeder cadre in Class-III and IV posts to the one eligible living spouse / dependent children of Martyr of Armed Forces Personnel/Para Military Forces Personnel, who was domicile of Haryana and is killed in action in border skirmishes, terrorist attacks or riots in addition to other financial benefits to the braved family on the following guidelines:-

- These instructions shall come into force w.e.f. 1st January, 2014.
- 2. "Martyr" means: a person serving in Armed Forces (Army, Navy and Air Force) or in Para Military Forces (BSF, CRPF, CISF, ITBP, Assam Rifles, Rapid Action Force etc.) under the Home Ministry on permanent basis and is killed in action in border skirmishes, terrorist attacks or riots and is declared Martyr by Ministry of Defence, Government of India and Ministry of Home Affairs, Government of India respectively.
- "Eligible family member" means; dependent son or daughter or wife who is not earning and is fully dependent upon the Martyr.

- 4. "Application" means; an eligible family member of the Martyr shall make an application for appointment as in form 'A' within a period of three years to the office of concerned Deputy commissioner who shall forward the same to office of Chief Secretary and office of Chief Secretary shall forward the application to the department where vacancy exists, for issuing appointment letter.
- "Appointment" means; the appointment under these instructions shall be confined to feeder posts in Group C and Group D category.
 The appointment under these instructions shall be made only on regular basis and against regular sanctioned post.
- "Exemption":- Appointments under these instructions shall be exempt from the observance of the recruitment through Recruiting Agencies notified by State of Haryana.
- 7. "Relaxation":- There shall be no relaxation of any provision of these instructions. However, as a special case, these instructions shall be relaxed only in the cases of children who have become orphan upon the demise of the Martyr. The claim of appointment of such orphans shall remain alive till one child of the deceased has attained majority/minimum eligible age for entry into Government service.
- 8. "Undertaking (by way of an affidavit)":- A person eligible to be considered for appointment under these instructions shall furnish an undertaking to the Government in Form 'C' that he/she shall maintain all the other members who were completely dependent on the Martyr; and in case it is proved subsequently, the family members are being neglected or are not maintained by him/her, his/her appointment may be terminated forthwith. (A condition to this effect shall also be inserted in his/her appointment letter).
- 9. "Interpretation" If any doubt arises relating to the application, interpretations and scope of these instructions it shall be referred to the Government in the department of General Administration (in General Services-II Branch) whose decision thereon shall be final.

Revised policy/instructions regarding payment of ex-gratia grant to the families/disabled personnel of Armed Forces (Army, Navy & Air Force) belonging to Haryana State killed/disabled in war/ in operational area, terrorist activities and natural calamities etc.

Kindly refer to this office memo No. 21/1/97-4D-III dated 16.01.2015 and dated 2.08.2016 on the subject noted above

The Governor of Haryana is pleased to enhance the rate of Ex-gratia grant to be given to Armed Forces Personnel (Army, Navy & Air Force), who get disabled in the performance of their bonafide official duties while serving in operational areas/in war/terrorist or military attack, Border Skirmishes and United Nation Peace Keeping Force etc. The grant Exgratia admissible under the policy/instruction shall be given in all cases of "Battle Casualty" as declared by the Defence Authorities, irrespective of any operation or any specified area of operation. The revised structure will be as under:-

The enhanced amount of ex-gratia is applicable to only those disabled Defence

who are residents of Haryana at the time of joining the service. That includes disabled personnel of battle casualty, who are boarded out due to disability or retained in service. Previous cases shall not be reopened. The ex-gratia amount can be claimed within three years of casualty. Thereafter, it will be time barred

- The grant of ex-gratia to disabled personnel of Defence Forces prior to issue of this
 policy will be given as per policy No. 21/1/97-41)-III dated 16-01-2015.
- 4. The Government of Haryana has decided that as long as personnel were a resident of Haryana at the time of joining/entry into the service in Defence Forces (Λrmy, Navy and Λir- Force). He should be given the cash award/annuity/Ex-gratia irrespective of his present residential address. In case individual's address at the time of joining service was a temporary one due to the place of posting of transferable Central Government employees, the domicile status would be decided on the basis of his father's permanent home address at the time of his joining service.(in terms policy No. 20/28/1985-4D-III dated 13.10.2016)
- All other conditions as contained in office memo No. 13/8/92-4DIII dated 30-09-99, policy memo No. 21/1/97-4D-III dated 15-06-2001, 21/1/97-4D-III dated 16-01-2015 and 2-08-2016 regarding grant of ex-gratia shall remain unchanged.
- The expenditure will be met out under Major Head "2235-Social Security & Welfare-60-Other Social Security & Welfare Programmes-200-Other Programmes (95) Rewards to Soldiers Sailors and Airmen for acts of gallantry in Kashmir campaign" etc.-34 other charges (P) Demand No. 22.
